Dear Members,

In accordance with rule 39 -50 of Dogs NSW constitution for Affiliates nominations are hereby called for office bearers and members of the committee of The Scottish Terrier Club Inc. for the year 2021 -- 2022

The constitution provides for alternative methods of voting:

1. By post or
2. At the Annual General Meeting to be held on the 28.11.2021

Any members desirous of exercising a postal vote must apply for a ballot paper at least 21 days prior to the Annual General Meeting ie. the Secretary must receive your application no later than 07.11.2021

Following this notice is a form to apply for a postal vote. You may use this or if you prefer, send a personal letter.

Eligibility to participate in election.

Only financial members of the club are eligible to nominate a candidate, stand for office or vote in the election.

Nominations must be made in writing, signed by the nominee and the nominator.

A financial member may nominate candidates for any or all positions vacant. Closing date for receipt of nominations is 07.11.2021

In accordance with rule 42, any position not nominated for or any vacancy occurring as a result of a member nominated declaring at the Annual General meeting (prior to the counting of the ballot ) unwillingness to stand for the position shall be filled by a ballot at the Annual General Meeting.

In the event a member stands for more than one position, upon election to a position the members name shall be automatically withdrawn from subsequent ballots.

Should only sufficient number of nominations fill positions vacant, they shall be automatically declared elected ( rule 43 )

A nomination form showing the positions to be filled, in all instances the necessary signatures must appear

REMEMBER: The final day for receipt of nominations is 01.11.2021 and the final day for lodging postal vote applications is 07.11.2021
