The club uses emails to

**1. Notify Members of special offers.**

We receive information on lecture nights and other offers at short notice when a newsletter is not yet due. In such cases, email is used to contact as many members as possible.

**2. Seek advice from members.**

This may be a specific question asked by a members requiring a rapid response. A health issue, where to get the best grooming etc.

**3. Distribute a Colour Version of our Newsletter**

The newsletter is one of the most significant costs for our club and members are encouraged to support the distribution of the newsletter by email to save trees and save the club money!

There are some members benefits as well.

- Members get a colour newsletter.
- Members can electronically store their newsletters making them easier to find in the future.
- Members get the Newsletter a couple of days earlier.

There will still be some letters delivered by Post. For example the yearbook.

**Personal Details**

To respect members privacy, we ask members to specify any details they want to exclude from publication such as the list of members in the Anniversary Yearbook etc.

**Cost of Membership**

The club has introduced a 3 year membership with a \$5 discount for dual members and \$4 discount for single members. The club encourages members to take the three year option as it reduces administration.

**Donations to Scottie Rescue.**

The club occasionally rescues Scotties whose circumstances have changed. Most times and costs incurred are recovered from the people who adopt the Scottie, but sometimes the vet bills, transport etc are too big and the club covers the shortfall. the club is always seeking extra funds to help Scottie Rescue.

**Direct Deposit of Membership Fees.**

The club has introduced the option to **Direct Deposit**. This will substantially reduce the clubs Bank Fees.

For people who use Money orders or Bank cheques, this option can save you money. **All you need to do is take the club BSB details and your reference number to a Commonwealth Bank Cashier with the required CASH and they will direct deposit it into the STC Account.** Internet Banking can also use the details below to transfer the funds. You need to check if there are any additional bank fees. You can make the transaction at other Banks as well, but this may incur additional Bank Fees.

It's very important that you use your **Surname and Initials as Reference Number** to allow the Treasurer to reconcile the Bank Statement. If you are using direct deposit also please send by post or email the date and amount of the deposit to assist the Treasurer cross reference the accounts. The club will accept a scanned email copy of your renewal saving you the cost of Postage.
